The estimated cost of injuries and ill health in the workplace was £16.2 billion in 2018/2019. The most common cause of long-term sickness absence is mental health and stress. According to the CIPD and Simply Health and Wellbeing Survey 2020, 37% of respondents cited stress-related absences as having increased in the last year.

Covid-19 has presented an additional challenge for employers in making workplaces Covid-secure with safe social distancing and adequate PPE. The increase of people working from home and the effects of Covid-19 on mental health are key challenges that must be addressed.






